Classes of Eligible Persons:

Class I: All full-time and part-time employees, including faculty members on a sabbatical trip. All students/participants of a sponsored international educational program enrolled at a participating EIIA member institution including alumni, chaperones, board members, trustees, spouses, domestic partners, dependent children, and other participants while traveling with a companion specifically to assist with any medical needs or community participants who may be filling spots on a trip but not otherwise a covered individual.
